## **Brief History**

Rockford native Sandra DeLannoy (1944-2009) graduated Rockford High School in 1962 and attended Illinois State University (ISU). At ISU, she earned a bachelors in English (1966) and then taught English at East Peoria High for a year. In 1967, she wed Garrett Scott and by the next year had earned a master's degree in counseling at ISU.

She and her husband, a speech therapist, raised two children, Garrett and Sarah.

From 1974 to 1979, Sandra Scott worked at local radio station WJBC as consumer advocate for their off-air "action line" helping individuals with consumer and governmental problems. Initially employed part time, she advanced to full time in 1977 as she added responsibility for coordinating promotions and later public service.

An active officer of the local League of Women Voters from 1968 onward, she resigned her post in 1974 to pursue a seat on the county board. She was elected that year and reelected in 1978. Her areas of focus included modernizing county government in the face of financial pressures, improving communications, financial viability of the county nursing home, and controlling residential encroachment into farmland areas. She served on the Environment, Justice, and Health Committees.

Scott resigned from the McLean County Board in late 1979 to become deputy director in the county's Building and Zoning Department, which issued building permits and investigated zoning requests. She served as director of the department from 1984 until her retirement in 1998. She was only the second woman to fill the role of county zoning director in the state of Illinois and became a role model for other women emerging in professions.

Her numerous community engagements included serving on the YWCA board, McLean County Board of Health, organizing board of Youth Services Agency, McLean County Mental Health Center (later called Center for Human Services), United Campus Christian Foundation Board, local chapter of Zonta International, and a variety of other local organizations.

A Lutheran in her youth, she became a Presbyterian and later one of the founding members and officers of the New Covenant Community Church in Normal in 1993-1994.

In her private life, she enjoyed reading, quilting, traveling and other activities.

# Scope

This collection includes an array of materials such as job resumes; samples of work at WJBC Radio (ads, public service announcements, conference presentations, etc.); county board campaign materials; campaign to eliminate election of selected county officers; sundry Building & Zoning Department materials; New Covenant Community church documents, especially from its formative period; and documents from other local organizations such as the Mental Health Center and local chapter of Zonta International.
